
2016 REPORT TO MEMBERS

THE PENSION PLAN

The UFCW Union Pension Plan (the “Plan”) is a jointly trusted pension plan. This means that the Plan is jointly managed by Trustees appointed by UFCW Local 1518, UFCW Local 247 and the employers. There is a Trust Agreement setting out the Trustees’ duties and responsibilities. They include ensuring that:

- proper records are maintained;
- the terms of the Plan are administered consistently and in accordance with the law; and
- the Plan funds are invested for the benefit of members and in accordance with the laws regulating pension plan investments.

One of the unique features of the Plan is that it has five separate divisions. The pension funds are combined for investment purposes, but a separate accounting for each division is maintained to ensure that the assets of one division are not used to support the benefits of another division. The divisions include:

- Overwaitea
- Safeway
- Tober Enterprises
- Miscellaneous
- Terminated Employers

INVESTMENT STRATEGY AND ASSET ALLOCATION

The Trustees of the Plan have adopted an investment strategy whereby the assets of the Plan are approximately matched to the liabilities of the Plan in terms of interest rate sensitivity and cash flows. Consequently, the Plan’s investments are in assets which have continued to deliver excellent protection for the benefits provided by the Plan. Most of the Plan’s assets are in fixed income investments such as Canadian and provincial government bonds, high quality corporate bonds and Canadian mortgages. The Plan also has investments in private debt and private equity as well as investments in income producing real estate such as Concert Properties and infrastructure investments. The Plan has very little exposure to public equities.

The Trustees' investment strategy for the Plan is designed to ensure that the benefits can be provided with a high degree of certainty. Annual actuarial valuations and asset / liability modeling analyses are performed to determine if any adjustments to the investment strategy are required. In between annual reviews, the Trustees' professional advisors monitor the performance of the assets, and provide regular updates. This ensures that the Plan continues to meet its goals and provide the level of pension benefits reported to members annually.

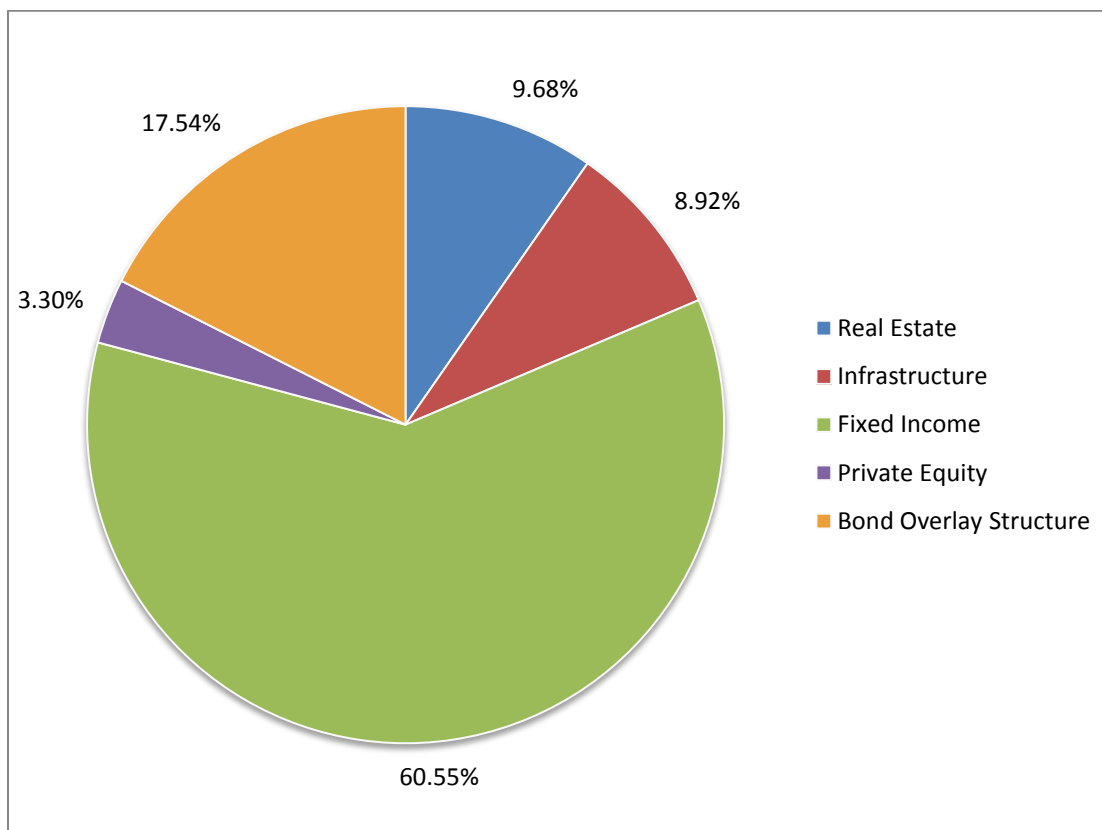
